Negotiation Skills in Mediation

SYMPOSIUM SPEAKERS

C. RICHARD BARNES may well be the most experienced labormanagement negotiator and mediator in the United States. In 1998, he was appointed by President Bill Clinton as the 14th Director of the Federal Mediation and Conciliation Service where he had previously served as Deputy Director and as a career mediator. In 1999, President Clinton also appointed Barnes to the National Partnership Council which provides oversight and direction to all federal agencies involved in workplace change initiatives.

Richard has mediated labor-management disputes between such labor unions as the Teamsters, the Machinists and the Longshoremen on the one hand, and the United Parcel Service, the Kennedy Space Center, Boeing and Kaiser Foundation Hospitals on the other.

Barnes also has extensive experience beyond the labor management field, having conducted regulatory negotiations involving such diverse matters as Native American Indian Self-Determination, the West Tennessee Tributary Project and the Panama Canal. He has also mediated environmental matters in which the U.S. Department of Justice and the Kelly Air Force Base were involved.

Mr. Barnes is on the visiting faculty at the Clinton School of Public Service at the University of Arkansas and on the adjunct faculty of the Strauss Institute for Dispute Resolution at Pepperdine University. He is President of C. Richard Barnes & Associates, providing dispute resolution services and systems design, workforce training and executive coaching nationwide

MICHAEL R. McMILLION is a Commissioner at the Federal Mediation and Conciliation Service, based in San Antonio. A lawyer with more than 35 years of experience, Mike has resolved many labor-management disputes during his tenure with FMCS, including a dispute between the Texas State Technical College System and the Texas Faculty Association. Upon reaching a resolution of that conflict, one of the parties said, "This settlement provides a model for how disputes could be settled in Texas institutions of higher education. Instead of years of contentious litigation that would have drained the time, energy, and resources of everyone involved, TSTC

and TFA have an opportunity to construct a new paradigm for faculty-administration relations based on managing conflict through the use of dispute resolution systems."

SUZANNE MANN DUVALL has more than 800 hours of basic and advanced training in alternative dispute resolution. She has mediated more than 2,500 cases to resolution specializing in the resolution of civil disputes including family law, contract and business law, real estate, employment, public policy, probate and related controversies. Licensed to practice law in the state and federal courts in Texas and California (inactive) and the United States Supreme Court, she is a faculty member and trainer for numerous dispute resolution and education organizations and a frequent lecturer and panel member for alternative dispute resolution seminars. She is a recipient of the First Annual American Arbitration Association Steve Brutsche Award for Professional Excellence in Dispute Resolution, the First Annual Tom Eisner Mediator of the Year Award for service to the courts and citizens of Tarrant County and several other awards distinguishing her as a committed leader and dedicated member of the alternative dispute resolution community.
