JUSTICE DEBRA H. LEHRMANN

Debra H. Lehrmann is the Senior Justice on the Supreme Court of Texas and the Court's longest-serving woman Justice in Texas history. She was a trial judge in Tarrant County for 23 years prior to her appellate service and has been an active leader in the legal community



on a state and national level throughout her career, including serving as chair of the ABA Family Law Section, inaugural chair of the SBOT Child Protection Law Section, chair of the Texas Chapter of the Association of Family and Conciliation Courts, chair of the Lloyd Lochridge Inn of Court, a commissioner on the ULC, and a member of the ALI. A strong advocate of mediation for many years, she served on the Advisory Board of and as a mediator for Tarrant County Dispute Resolution Services.

MARK NAIR

Mark is a seasoned innovator with over 25 years of experience in digital content, innovation, and distribution. He is a member of the National Academy of Inventors, is a National Science Foundation I-Corps mentor, and holds an extensive patent portfolio. A tech
